November 7 – December 16, 2016	Window to manage participation information in PearsonAccess ^{next™} .
November 7, 2016 – January 20, 2017	Window for test coordinator to submit requests for ACT-approved accommodations in the Test Accessibility and Accommodations System (TAA).
November 7, 2016 – January 26, 2017	Online testing only Test and technical coordinators begin technical site readiness and install ProctorCache software for online testing. <i>Note: If your school does not install ProctorCache software within this window, ACT will switch your administration from online to paper.</i>
December 6, 2016	Accommodations Q&A session(s)
December 19, 2016 – January 26, 2017	Window for district to submit Student Data Upload (SDU) file/update student screen via PearsonAccess ^{next} for initial ACT test materials. Important! Updates completed during this window will generate barcode labels and derive the enrollment counts for your initial order. <i>Note: Anyone at the district or school level can add or update individual students.</i>

Examinees who are newly enrolled or a newly classified grade level with previously approved ACT-approved accommodations. 4. Examinees with medical emergencies or sudden onset of a medical condition.

February 28 – March 3, 2017	Window for test coordinator to submit makeup order for standard time ACT materials. (paper testing only)
February 28 – March 14, 2017	ACT online testing window ACT accommodations testing window
March 1, 2017	Test coordinator returns all initial test date materials via the prescheduled pickup.
March 6 – 15, 2017	Window to add additional students or update existing student information in PearsonAccess ^{next} for the makeup test date.
March 10, 2017	Deadline for ACT to receive answer documents from schools for the initial test date. Late arriving documents will not be scored.
March 13 – 17, 2017	Test coordinator receives makeup shipment(s) (containing standard time materials) for paper testing.
March 13 – 20, 2017	Window for schools to conduct pretest sessions for the makeup test date. (paper testing only)
March 15, 2017	Test coordinator returns all online and accommodations testing materials via the prescheduled pickup.
March 15 – 17, 2017	Online testing only Window for technical coordinator to purge test content from ACT online testing.
March 21, 2017	Makeup test date (paper testing)
March 22, 2017	Test coordinator returns all makeup test date materials via the prescheduled pickup.
March 24, 2017	Deadline for ACT to receive answer documents from schools for the accommodations test window. Late arriving documents will not be scored.
March 31, 2017	Deadline for ACT to receive answer documents from schools for the makeup test date. Late arriving documents will not be scored.
Beginning late March (3–8 weeks following receipt of examinee test responses)	Students, schools, and colleges begin to receive ACT Student Reports, High School Reports, and Student College Reports.
